- i) The question paper should contain two parts A & B. Each part includes three questions of 15 marks each. Students will have to answer two questions from each part.
- ii) The topics to be included in each part is decided as given below.
PART A :- Construction of grouped frequency table, Diagrammatic and graphical analysis of data, Random number generation, descriptive statistics and comparison, curve fitting and graphical analysis using observed and estimated values, scatter diagram, correlation , regression and forecasting.
PART B :- Fitting of distributions, interval estimation and testing of mean, variance and proportion of single population, test for the comparison of mean and variance of two normal populations, Test for goodness of fit, independence and homogeneity, Checking the validity of normality assumptions (skewness and kurtosis), One way and two way ANOVA.
- iii) The pattern may be followed for the practical question of **Statistics core course** by making necessary changes in the topics.


The committee entrust Dr.Veena T.G. and Mr.Hari V.G. to prepare model question paper for the complimentary and core course respectively.
